AN ORDINANCE APPROVING THE FISCAL YEAR 2020 OPERATING BUDGET FOR THE PORTSMOUTH PUBLIC SCHOOL SYSTEM IN THE AMOUNT OF \$199,605,957 AND APPROPRIATING THE NECESSARY FUNDS TO IMPLEMENT SAID BUDGET FOR THE FISCAL YEAR 2020.

BE IT ORDAINED by the Council of the City of Portsmouth, Virginia:

1. The Fiscal Year 2020 Operating Budget in the amount of \$199,605,957 for the Portsmouth Public Schools is hereby approved in the following revenue and expenditures:

- 2. All unspent appropriations under this ordinance or any ordinance appropriating funds for the FY 2020 Portsmouth Public Schools budget shall lapse at the end of the fiscal year, as provided under Section 22.1-100 of the Code of Virginia. Funds encumbered but unpaid by the end of the fiscal year will be deemed unspent appropriations that will require re-appropriation by the City Council.
  - 3. The FY 2020 local share of \$55,396,045 shall be delivered to Portsmouth Public

Schools in twelve equal monthly payments.

- 4. The city funds listed as revenues in this budget include the amount of \$2.6 million to be used by Portsmouth Public Schools for a 3% salary increase for teachers and employees, as requested by Portsmouth Public Schools.
  - 5. This ordinance shall take effect on July 1, 2019.
